ARTICLES OF INCORPORATION

ARTICLÈ I

The name of the Corporation shall be: DON TOSTON, INC.

ARTICLE II

The general nature of the business and the objects and purposes to be transacted and carried on by this Corporation shall be:

(a) To engage in all business and activities permitted under the Laws of the State of Florida / or in any other State in The United States of America.-
