ARTICLE I
Name of Corporation

Joseph G. Thomas, Inc.

ARTICLE II
Business of Corporation

The corporation may engage in the business of operating a medical practice, and may also engage in any other lawful activity or business permitted under the laws of the United States and of the State of Florida.

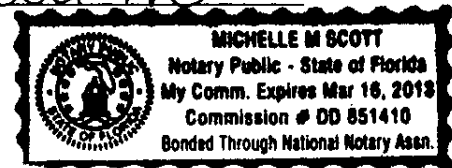
