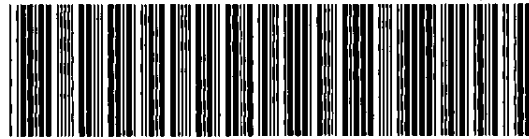

**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is TACTICAL TEACHING, INC., and the principal address and principal place of business is 3819 LAKE SHORE DRIVE, PALM HARBOR, FLORIDA 34684.

ARTICLE II - REGISTERED OFFICE AND AGENT
