ARTICLES OF INCORPORATION SECRETARY OF STATE

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act adopts the following Articles of Incorporation:

ARTICLE I
CORPORATE NAME AND PRINCIPAL OFFICE

The name of this corporation is WOUND HEALING INSTITUTE OF FLETCHER, INC. (the "Corporation") and its principal office and mailing address is 16606 Villalenda De Avila, Tampa, Florida 33613.

ARTICLE II


ARTICLE VII


