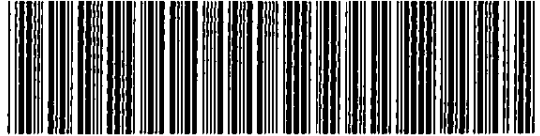

ARTICLE I - NAME & ADDRESS


