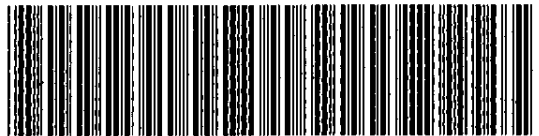

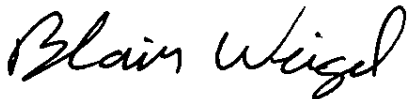

The undersigned, acting as incorporator, of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I - NAME

The name of this corporation shall be NATIONAL CONSULTANTS, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal office and mailing address of this corporation is 7222 South Tamiami Trail, Suite 104, Sarasota, Florida 34231.

ARTICLE III - NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK

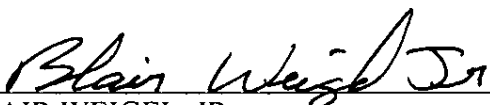

The effective date of the incorporation of this business shall be upon the filing of these Articles with the Secretary of State's office.

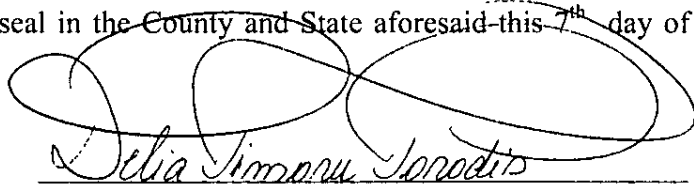
