ARTICLES OF INCORPORATION OF LAW OFFICE OF DIANE M. McGUIRE, P.A.

A Florida Profit Professional Association (Pursuant to Chapter 607 and 621, Florida Statutes)

The undersigned person has signed this document for the purpose of forming a corporation under the laws of Florida and adopts the following Articles of Incorporation.

- 1. Name. The name of this corporation is LAW OFFICE OF DIANE M. McGUIRE, P.A..
- 2. <u>Purpose and Powers.</u> This corporation is organized for the transaction of any and all lawful legal professional services.
- 3. <u>Authorized Capital.</u> The corporation shall have the authority to issue 1000 shares of common stock.
