ARTICLE I

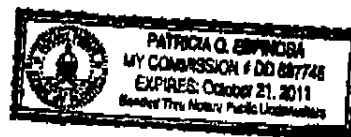


