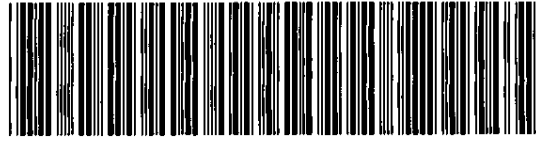

We, the undersigned subscriber to these Articles of Incorporation, natural persons Competent to contract, hereby form of Corporation under the Laws of the State of Florida.

**ARTICLE I- NAME OF CORPORATION**

The Name of the Corporation shall be:

**MIAMI'S CAFÉ TV, INC.**

**ARTICLE II- GENERAL NATURE OF THE BUSINESS:**

The General nature of the business and the object and purpose to be transacted and carried on are:

To conduct any and all business not prohibited by the laws of the United States and State of Florida.

To Conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights and licenses, in the State of Florida and in other states and other countries. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness and execute such mortgages, transfer of corporate properties, or other instruments to secure the payments of corporate indebtedness as required.

To purchase the Corporate assets or any other Corporation and engage in the same or other character of business. To Guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds securities, or other evidences of indebtedness created by any other Corporation of the State of Florida or any othe state or government, and while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.

**ARTICLE III, CAPITAL STOCK:**

The maximum number of shares of stock that the Corporation is authorized to have, outstanding at any one time is **200,000** shares at **0.10** par value. Such stocks may be issued by the Corporation from time to time for such consideration as may be fixed by the Board of Directors thereof, and may be paid in cash, labor or services.

**ARTICLE IV, INITIAL CAPITAL:**

The number of shares with which this Corporation shall commence business is not less than **200,000** shares common stock, and the amount of Capital with which this Corporation shall commence business not be less than **TWENTY THOUSAND DOLLARS -----(\$20,000)**.

**ARTICLE V, TERM:**

The Corporation shall continue perpetually, unless sooner dissolved according to Laws.

**ARTICLE VI, PRINCIPAL PLACE OF BUSINESS:**
