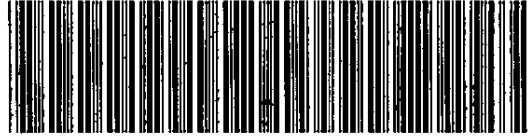




FIRST: The Articles of Incorporation of the Corporation are hereby amended by deleting Article I in its entirety and by substituting the following new Article I in lieu thereof:
