### ARTICLES OF INCORPORATION OF DEAN HECHT'S GLASS SERVICE, INC.

ARTICLE I: The name of this corporation is DEAN HECHT'S GLASS SERVICE, INC.

ARTICLE II: This corporation shall have perpetual existence.
