OF
LLAIMA ASSOCIATES, INC.,
A FLORIDA CORPORATION**

**ARTICLE I
NAME**

The name of the corporation shall be Llaima Associates, Inc., a Florida corporation.

**ARTICLE II
PRINCIPAL OFFICE**

**ARTICLE III
PURPOSE AND POWERS**
