ARTICLES OF INCORPORATION OF DRESSED HAUTE, INC.

The undersigned, acting as Incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I-NAME

The name of the Corporation shall be DRESSED HAUTE, INC.

ARTICLE II-PRINCIPAL OFFICE

The principal office of this Corporation shall be located at 1105 Greenwood Street, Orlando, Florida 32801.

ARTICLE III-DATE OF EXISTENCE

This Corporation shall exist perpetually, commencing on the date of filing of these Articles of Incorporation.

ARTICLE IV-INDEMNIFICATION

This Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE V- RESTRICTIONS ON STOCK

The shareholders of the Corporation may enter into written agreements concerning the transfer, voting, redemption, or issue of shares of stock of the Corporation provided that such agreements (1) are in writing and (2) comply with the provisions of the Florida Business Corporation Act, Florida Statutes 607.0101 et seq. Copies of any agreement which by its terms affects the transfer, voting, redemption, or issue of shares of stock of the Corporation shall be maintained at the principal office of this Corporation.

ARTICLE VI-CAPITAL STOCK

The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is Ten Thousand (10,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

ARTICLE VII-INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The initial street address of the registered office of this Corporation in the State of Florida shall be 112 E. Concord Street, Orlando, Florida 32801.
