The undersigned Incorporator hereby executes these Articles of Incorporation, in order to form a Corporation under the laws of the State of Florida.

Article One - Name

The name of this Corporation shall be henceforth be known as "**PAIGE LAW GROUP P.A.**".

Article Two - Nature of Business

The general nature of the business to be transacted is to engage in every phase and aspect of the business of rendering the same professional services to the public that an attorney at law, duly licensed under the State of Florida, is authorized to render and to do such other acts as otherwise permitted by law.

Article Three - Capital Stock

The maximum number of shares that this Corporation shall be authorized to have outstanding at any one time is one hundred (100) shares of common stock, having a nominal or par value of One Dollar (\$1.00) per share.

Article Four - Term of Existence

This Corporation is to exist perpetually.

Article Five - Principal Address

The initial principal address for this Corporation in this State shall be 9500 South Dadeland Boulevard, Suite 550, Miami, Florida 33156, though the Board of Directors may from time to time move the principal office to any other address in Florida.

#### Article Six - Registered Agent

The initial Registered Agent for this Corporation shall be Robert E. Paige, Esq., whose address is Suite 550, 9500 South Dadeland Boulevard, Miami, FL 33156, and this address shall also be known as the "Registered Office".

#### Article Seven - Directors

The Corporation shall have one Director initially. The number of Directors may be increased or diminished from time to time, by By-Laws adopted by the shareholders, but shall never be less than one.

The name and address of the initial Director is: Robert E. Paige, Suite 550, 9500 South Dadeland Boulevard, Miami, FL 33156.

#### Article Eight - Effective Date

These Articles of Incorporation shall be effective upon the Florida Secretary of State accepting and filing these Articles of Incorporation.

#### Article Nine - Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### Article Ten - Restrictions on Transfer of Shares

The Corporation shall have the right of first refusal as to any proposed transfer of shares.

#### Article Eleven - Incorporator

The name and address of the person signing these Articles of Incorporation is: Robert E. Paige, Suite 550, 9500 South Dadeland Boulevard, Miami, FL 33156.

Article Twelve - Amendment

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the shareholders, and approved at a stockholders' meeting by a majority of the stock entitled to vote thereon unless all of the Directors and the shareholders sign a written statement manifesting their intention that a certain amendment to these Articles of Incorporation be made.

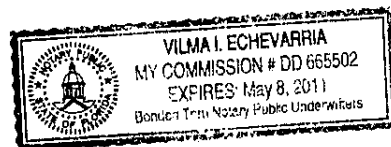
