The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation:

FIRST. The name of the corporation (hereinafter called the "corporation") is Naomi Katzowitz, DVM, P.A.

SECOND. The street address and mailing address of the initial principal office of the corporation is 13604 Firewood Court, Wellington, Florida 33414.

THIRD. The purpose of the corporation is to engage in every phase and aspect of the business of rendering professional veterinary services and any other lawful business, act or activity that may be engaged in by a professional corporation formed for such purpose pursuant to the Professional Service Corporation and Limited Liability Company Act.


FOURTH. The total number of shares that the corporation is authorized to issue is One Thousand (1,000) shares of Common Stock, \$.01 par value per share.


