ARTICLES OF INCORPORATION

OF

The undersigned subscribers, natural persons competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida, Chapter 607, and subject to the following provisions:

ARTICLE I-NAME

The name of the corporation shall be:

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of the Articles of Incorporation.

ARTICLE III- PURPOSE

- This corporation is organized for the purpose of transacting any or all lawful business concerning the practice of real estate , including but
- not limited to: a. Any and all lawful business.
- b. Pursue its purposes and business in any and all locations foreign and domestic.
- c. Acquire, own, hold, develop, deal in and with, maintain and operate, unlimitedly, such real and personal property of every kind and description within and without the State of Florida.
- d. Buy and sell real and personal property of any nature whatsoever.
 e. Convey, sell, assign, transfer, lease, mortgage, pledge, exchange or otherwise deal with any property.
- Import and export wares goods and merchandise of any nature whatsoever.

- products and supplies of every kind, character and nature.

 h. Purchase, hold, sell, transfer or deal in any manner with or in stocks, bonds, obligations, securities or interests of its own, cr of any other person, firm or corporation.
- 1. Pay cash or issue capital stock, debentures, bonds, mortgages, or other obligations of the corporation for any acquisition by the corporation and for any other lawful purpose.
- Engage in the acquisition, ownership, sale, distribution and licensing of patents, improvements and franchises, trademarks and
- trade names, and to operate thereunder.

 k. Enter into, make and perform contracts of every kind and description with any person, firm or association, corporation and body politic conducive to the attainment of any of the objectives or purposes of the corporation.

The Director of this corporation shall have the power to make or amend the bylaws and to fix any amount to be reserved for working capital. The private property of the stockholder/s shall not be subject to the payment of the corporate debts in any extent whatever. The corporation shall have a first lien on the shares of its members and upon the dividends due them or any indebtedness of such members of the corporation.
