THE UNDERSIGNED HEREBY MAKES, SUBSCRIBES, ACKNOWLEDGES AND  
FILES THE FOLLOWING ARTICLES OF INCORPORATION:

**ARTICLE I**

THE NAME OF THIS CORPORATION SHALL BE:

**ARTICLE II**

REQUIRED.

(7) TO DO ALL THINGS ENUMERATED, SET FORTH AND AUTHORIZED BY FLORIDA STATUTES 1975, SECTION 607.011.

#### **ARTICLE V**

THE MAXIMUM NUMBER OF SHARES OF STOCK THAT THIS CORPORATION IS AUTHORIZED TO HAVE OUTSTANDING AT ANY TIME SHALL BE AS FOLLOWS: 1,000,000 SHARES AT ONE DOLLAR (\$1.00) PAR VALUE.
