### ARTICLE 1 - NAME

# ARTICLE 2 - PURPOSE OF CORPORATION

# ARTICLE 5 - CORPORATE CAPITALIZATION

- 5.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is **TEN THOUSAND (10,000)** shares of common stock, each share having the par value of **ONE CENT (\$.01)**.

# **ARTICLE 15 - INDEMNIFICATION**
