ARTICLES OF INCORPORATION

OF

TURF TRIMMERS OF SOUTH FLORIDA, INC.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

ARTICLE I

The name of the corporation shall be TURF TRIMMERS OF SOUTH FLORIDA, INC. hereinafter referred to as the Corporation. The principal and main mailing address is as follows: 18570 SW 294th Terrace, Homestead, Florida 33030.

- F) To borrow money and contract debts when necessary for the transaction of its business or for the exercise of its corporate rights, privileges and franchises, or for any other lawful purpose of its incorporation; to issue Bonds, Promissory Notes, Bills of Exchange,

Debentures, and other obligations and evidences of indebtedness payable at a specified time or payable upon the happening of a specified event, whether secured by mortgage or unsecured, for money borrowed or in payment for property purchased or acquired, or any other lawful objects.
