TO THE ARTICLES OF INCORPORATION OF

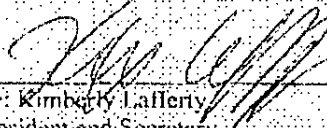
1. The name of the Corporation is Americas Currency Exchange Corp.
