We, the undersigned, do hereby associate ourselves together and subscribe The Articles of Incorporation for the purpose of forming corporation under the Laws of the State of Florida, Chapter 607 and subject to the following provisions:

ARTICLE ONE

The name of the Corporation shall be E.L. IMPORT & EXPORT CORP.

This corporation shall have perpetual existence and may engage in any Activity or business permitted under the laws of the United States of Florida.

ARTICLE TWO

The general nature of business to be transacted by this corporation shall Be:

- e) To purchase the corporate assets of any other corporation and engage in the same or Other character of business.
- f) To acquire by purchase subscription or otherwise and to receive, hold, Own, guarantee, Sell, assign, exchange, underwrite, transfer, mortgage, pledge or otherwise dispose of Or deal in and with any of the shares of the capital stock or any Voting trust

ARTICLE THREE

The maximum number of shares of stock, which the corporation shall have Outstanding at any time, shall be 500 shares of common stock _____ \$2.00 par Value, _____

All or any part of the capital stock may be paid for either in lawful monies of the United States of America, or in other assets transferred to the corporation, at ;1 true valuation as of the time of the exchange for stock.

ARTICLE FOUR

ARTICLE FIVE

Any director, individual or any firm of which any director may be a member, may be a party to, or may be pecuniary or otherwise interested in any contract or transaction of the corporation, provided the fact that his interest should be disclosed or should have been known to the Board of Directors or such members thereof as shall be present at any meeting of the Board of Directors at which action upon any such contract or transaction shall be taken, and any director of the corporation who is so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of the Corporation which shall authorize any such contract or transaction, with the like force and effect as if he were no such director or officer of such other corporation or not so interested.

ARTICLE EIGHT


