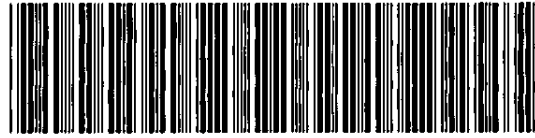

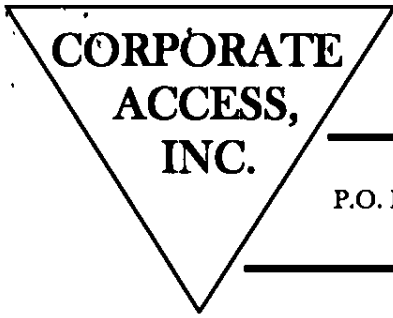

ARTICLES OF INCORPORATION OF

The undersigned incorporator, for the purposes of forming a corporation under Chapter 621, Florida Statutes (2009) known as the Professional Service Corporation and Limited Liability Company Act, hereby adopts the following Articles of Incorporation.
