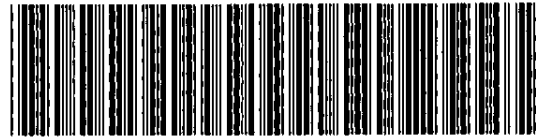



The undersigned incorporator for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST: The name of the Corporation is **Abraham Laeser, P.A.** (The Corporation).
- SECOND: The principal office address and mailing address of the Corporation is 1525 Daytonia Road, Miami Beach, FL 33141
- THIRD: The Corporation is authorized to issue 7,500 shares of common stock, par value \$1.00 per share.
- FOURTH: The street address of the initial registered office of the Corporation is: 1525 Daytonia Road, Miami Beach, FL 33141, and the registered agent is Abraham Laeser.

- SIXTH: This corporation is organized to engage in every phase and aspect of law and such professional services shall be rendered only through officers, employees and agents who are duly licensed under the laws of the State of Florida to practice such profession. It is hereby expressly provided that the foregoing enumeration of a specific purpose shall not be held to limit or restrict in any manner the purpose of this corporation otherwise permitted by law.

The Corporation is also organized for the purpose of transacting such other lawful business for which corporations may be formed under Chapter 607 of the Florida Statutes, and in compliance with Chapter 621 of the Florida Statutes as a Professional Association.

- SEVENTH: The Corporation shall have one director initially and the number of directors may be increased or diminished from time to time as provided in the Bylaws but shall never be less than one. The name and address of the initial director of the Corporation is:

EIGHTH: The Corporation expressly elects not to be governed by Section 607.0901 of the Florida Business Corporation Act, as amended from time to time, relating to affiliated transactions.

NINTH: The Corporation expressly elects not to be governed by Section 607.0902 of the Florida Business Corporation Act, as amended from time to time, relating to control share acquisitions.
