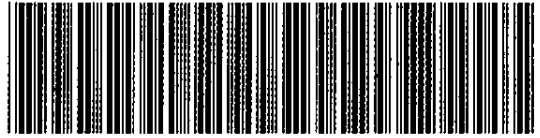



ARTICLE I - NAME

The name of this corporation is PROFESSIONAL SPORTS FORECASTING, INC.

ARTICLE II - DURATION

This corporation shall have a perpetual existence.

ARTICLE III - PURPOSE


