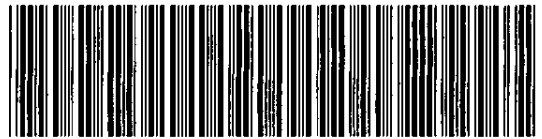

**ARTICLES OF INCORPORATION**

I, Barry M. Macchione, being one of the incorporators to these Articles of Incorporation, hereby adopt the following Articles of Incorporation for such corporation under the laws of the State of Florida.

**ARTICLE I.**  
**NAME**

The name of this corporation is: Main Street DoJo's, Inc.

**ARTICLE II.**  
**NATURE OF BUSINESS**

This corporation may engage in any or all lawful activity or business permitted under the laws of the state of Florida and of the United States.

**ARTICLE III.**  
**CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to issue is One Hundred (100) shares, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

**ARTICLE IV.**  
**DATE AND TERM OF CORPORATE EXISTENCE**

This corporation shall begin its existence immediately and shall exist perpetually thereafter.

**ARTICLE V.**  
**PRINCIPAL OFFICE**

The initial address of the principal office of this corporation shall be 360 Vail Drive, Winter Haven, Florida 33884. The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE VI.  
DIRECTORS

This corporation shall have four directors initially. The number of directors may be increased or decreased from time to time by the By-laws adopted by the stockholders, but shall never be less than one.

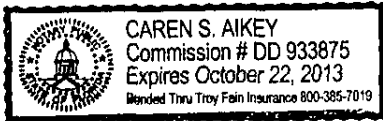
