ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Wade Group Inc. Its principal office and mailing address is 3850 Bird Road, Suite 902, Miami, Florida 33146.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.




ACCEPTANCE OF REGISTERED AGENT
