ARTICLES OF INCORPORATION OF AOUARII SERVICES, INC.

ARTICLE I - NAME

The name of this corporation is AQUARII SERVICES, INC.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The street address of the principal office and the mailing address of the corporation shall be 255 Old Sanford Oviedo Road, Winter Springs, Florida 32708.

ARTICLE III - CAPITAL STOCK

- 1. Number and Classes of Shares Authorized. The total number of shares of all classes of capital stock which the Corporation shall have authority to issue is One Thousand (1,000) shares, of which One Hundred (100) shall be shares of Class A Common Stock, and Nine Hundred (900) shall be shares of Class B Common Stock. The par value of both classes of Common Stock shall be one cent (\$.01) per share. The Class B Common Stock shall not have or possess any voting rights for any purpose, except those required by law. Except for the difference in voting rights, the Class A Common Stock and the Class B

Common Stock shall be the same in all other respects and shall have all the same rights and entitlements.

3. Preemptive Rights. No shareholder of the Corporation shall have the right, upon the sale for cash or otherwise, of any new stock of the Corporation held by it in its treasury or otherwise, of the same or any other kind, class or series as that which such shareholder already holds, to purchase a pro rata or any other share of such stock at the same price at which it is offered to others by the Corporation or for any other price.
