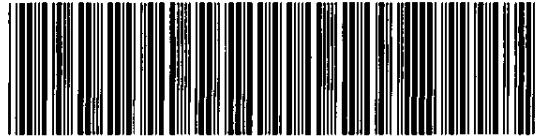

ARTICLES OF INCORPORATION OF
AEROTOOL, INC.

The undersigned, acting as Incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation:

ARTICLE ONE

The name of this corporation shall be: AEROTOOL, INC.
