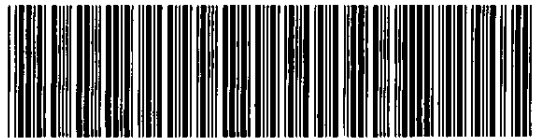

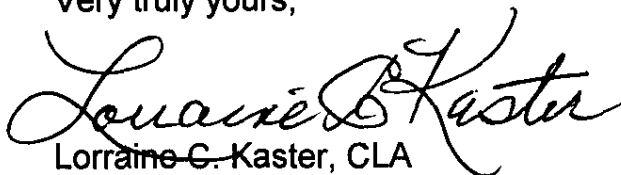

ARTICLE I - Name

The name of the corporation shall be: **PRIDE SERVICES & MAINTENANCE, INC.**

ARTICLE II - Duration

This corporation shall exist in perpetuity commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III - Purpose

This corporation is organized for the purpose of transacting any and all lawful business, including, but not limited to the following: services relating to construction and its maintenance, such as: pressure washing, painting, pot hole repair, driveways, signs, wallpaper and related activities, (janitorial, excluded.)

ARTICLE IV - Capital Stock

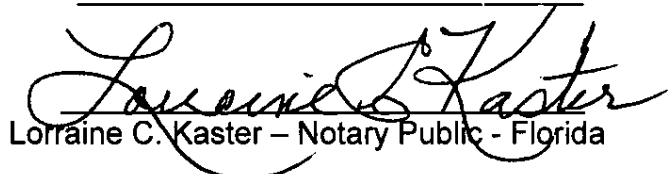

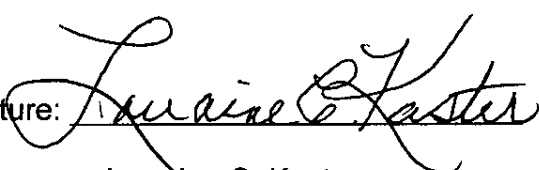
