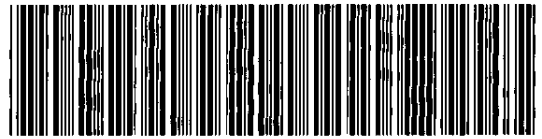

In compliance with Chapter 607 and/or Chapter 621, F.S. (Profit), the undersigned, acting as incorporator under the provisions of the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of this corporation shall be: **WORLDWIDE ASSESSMENTS GROUP, INC.**

ARTICLE II PRINCIPAL OFFICE



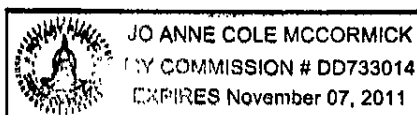


