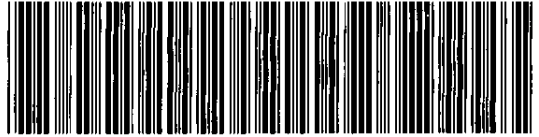

ARTICLES OF INCORPORATION

OF

HOME BASE, INC.,
a Florida corporation

In compliance with Section 607, Florida Statutes, the Articles of Incorporation of the above Corporation are as follows:

ARTICLE I - NAME

The name of the Corporation is HOME BASE, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and the mailing address of this corporation shall be 8187 23rd Avenue North, St. Petersburg, Florida 33710.

ARTICLE IV – PURPOSE

The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE V – AUTHORIZED SHARES

The aggregate number of shares that the corporation is authorized to issue is 100 shares of capital stock with a par value of \$1.00 per share. The shares of the corporation are not to be divided into classes. 

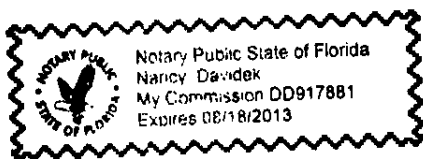
