#### ARTICLE II - NAME

The name of this corporation shall be:

#### **ARTICLE III - PURPOSE**

The general nature of the business to be transacted by this corporation is:

To engage in every phase and aspect of the business of rendering the same professional services to the public that attorneys duly licensed to practice law under the laws of the State of Florida are authorized to render, but such professional services shall be rendered only through the corporation's officers, employees and agents who are duly licensed or otherwise legally authorized under the laws of the State of Florida.

To invest its funds in real estate, mortgages, stocks, bonds or other type of investments and to own real and personal property necessary for the rendering of the above-described professional services.

To do all and everything necessary and proper for the accomplishment of any of the objects or purposes enumerated in these Articles of Incorporation or any amendment thereto, or in the furtherance thereof or necessary or incidental to the protection and benefit of the corporation, and in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes or the attainment of the objectives for which this corporation is formed, and to have all of the powers conferred upon this corporation by the laws of the State of Florida or any other state or country and not prohibited by the Professional Service Corporation Act.

The objects and purposes specified in the foregoing clauses of this Article, unless expressly limited shall not be limited or restricted by reference to, or inference from, any provision in this or any other Article of these Articles of Incorporation, shall be regarded as independent objects and purposes all as permitted by law.

#### ARTICLE IV - CAPITAL STOCK

The authorized capital stock of this corporation shall consist of one hundred thousand (100,000) shares of common stock having a par value of \$1.00 per share. None of the shares of capital stock of this corporation may be issued to anyone other than an individual duly licensed or otherwise legally authorized to practice law in the State of Florida. The shares of capital stock of the corporation shall be issued for such consideration as may be determined by the shareholders.

#### ARTICLE V - TERM OF EXISTENCE

This corporation shall begin existence on February 15, 2010, and shall exist perpetually unless dissolved according to law, or dissolved by the shareholders.

#### ARTICLE VI - ADDRESS OF PRINCIPAL OFFICE
