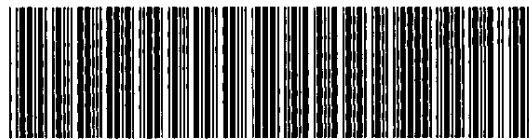

On August 6, 2010, the Board of Directors of **SQUADRON MARKETING, INC.** duly adopted the following amended and restated articles of incorporation pursuant to the provisions of Sections 607.1005 and 607.1007 of the Florida Business Corporation Act:

ARTICLE I

Name

The name of the corporation is Squadron Marketing, Inc. (hereinafter called the "Corporation").

ARTICLE II

Principal Office

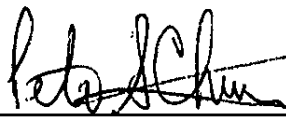
ARTICLE VI
