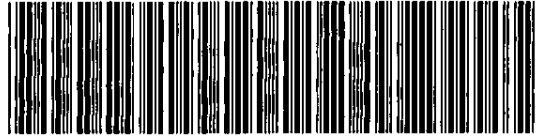





## Buy/Sell Agreement

This Contract is made on 1-28-2010, 2010, between **Leon Mobley**, whose address is 1301 Royal Palm Beach Blvd., Royal Palm Beach, FL 33411, and **Kena Farley**, whose address is 1301 Royal Palm Beach Blvd., Royal Palm Beach, FL 33411.

For valuable consideration, the parties agree as follows:

To form a Florida Corporation named Great Florida Tax Service of South Florida, Inc;

That each of the two parties will contribute \$5,000.00 (Five Thousand Dollars) to the corporation no later than 6-1-2010, 2010, and each will receive 5,000 shares of the corporation at the time the contribution is made;

That either or both parties may withdraw from this agreement if BOTH parties have NOT made the prescribed contribution by the date set forth in the prior paragraph;

That if either party desires to buy the other party's shares or sell their shares to the other party, any offer to buy or sell will automatically operate as BOTH a buy offer and a sell offer for the same number of shares and at the same share price as in the original stated offer. For example, if Party A offers to buy 5,000 shares from Party B for \$10,000, then Party B has the right to sell his shares to Party A for \$10,000 or Party B has the right to buy 5000 shares from Party A for the same amount (\$10,000).

No modification of this Contract will be effective unless it is in writing and is signed by both parties. This Contract binds and benefits both parties and any successors. Time is of the essence in this contract. This document, including any attachments, is the entire agreement between the parties. This Contract is governed by the laws of the State of Florida.
