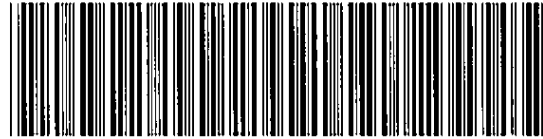

THIRD: The dissolution was authorized on September 23, 2022.

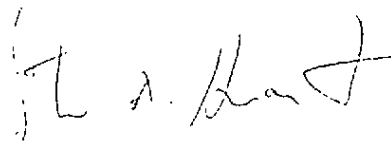

FIFTH: This Articles of Dissolution are effective as of September 30th, 2022.

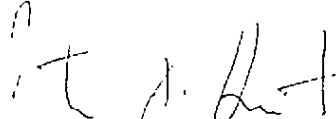
