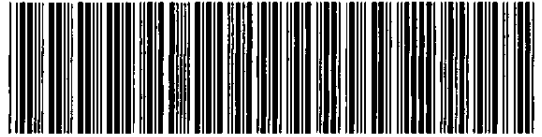

*The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

**ARTICLE I: NAME**

The name of the corporation shall be: CERTAINTY SERVICES, INC.

**ARTICLE II: PRINCIPAL OFFICE**

**ARTICLE III: EXISTENCE AND DURATION**

This corporation shall exist perpetually commencing on February 12, 2010.

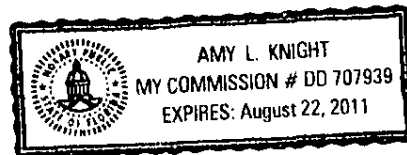


