**ARTICLES OF INCORPORATION
OF

**ARTICLE I

The total authorized capital stock of the corporation shall be one hundred (100) shares of common stock, \$0.01 par value per share.

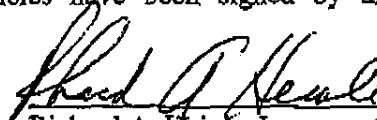
**ARTICLE IV

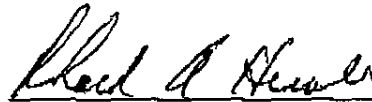
