ARTICLES OF INCORPORATION OF REEFER INVESTOR 2, INC.

THE UNDERSIGNED, acting as sole incorporator of REEFER INVESTOR 2, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE 1 NAME
