Article One

The general nature of business or businesses to be transacted will be to Distribute Woman and men's lingerie and other clothing related products in the United States of North America or any foreign country or countries, to buy, sell, import, export, lease, sub-lease, hold, procure, transport, acquire and deal generally, both wholesale and retail, in goods and services of all type, both as principal and agent in any part of the world.

We will not manufacture any product, at least originally, but rather, will act as the operating arm of manufacturing companies that produce the type of products requested by our clients at their desired configurations and ascertaining that they are in compliance with all their specific requirements.

We plan to establish entities in several different locations overseas, chartered as branches of Naughty Girls, Inc a foreign corporation housed in Florida.

To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidence of indebtedness, execute mortgages, transfer of corporate property or other instrument to secure the payment of corporate property or other instrument to secure the payment of corporate property indebtedness as required. To seek independent distributors or investors to promote in a franchise type structure our product. Furthermore:

This corporation may engage in any activity or business permitted under the laws of the United States of America and laws of the State of Florida, including all of the above, but not limited to same.


