**ARTICLES OF INCORPORATION
OF**

AFL SERVICES, INC.

The undersigned, acting as incorporator of AFL SERVICES, INC. under Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is AFL SERVICES, INC. (the "Corporation").

ARTICLE II. MAILING ADDRESS AND OFFICE


ARTICLE VIII. BYLAWS
