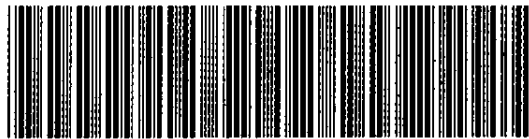

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be: KIHLSTROM DEVELOPMENT ENTERPRISES, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 5388 Skylark Manor Drive, Jacksonville, Florida, 32257.

ARTICLE III: EXISTENCE AND DURATION

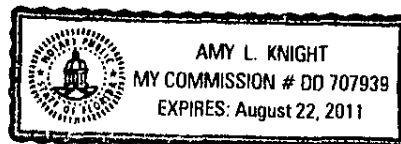
