

ARTICLES OF INCORPORATION

OF

KIHLSTROM DEVELOPMENT ENTERPRISES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation

Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be: <u>KIHLSTROM DEVELOPMENT ENTERPRISES</u>, INC.

ARTICLE II: PRINCIPAL OFFICE
