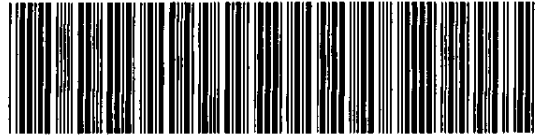

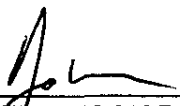
ARTICLE IX

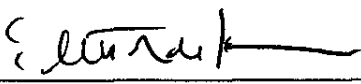
