**Articles of Incorporation  
of  
KCtone Technology, Inc.**

Pursuant to Chapter 607 of the Florida Statute (the "Florida Business Corporation Act"), the undersigned, hereby adopts the following Articles of Incorporation:

**ARTICLE I NAME AND PRINCIPAL OFFICE**

The name of the corporation shall be KCtone Technology, Inc. (hereinafter the "Corporation"), and the principal office shall be at 2102 Camp Indianhead Rd., Suite B, Land O Lakes, FL 34639-5274.

**ARTICLE II DURATION**

The period of duration of the Corporation shall be perpetual.
