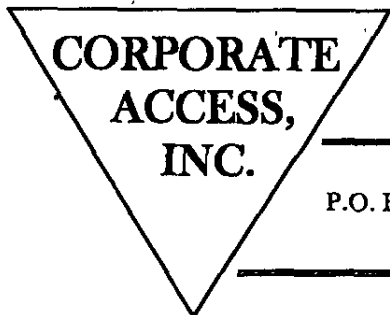


ARTICLE SEVEN - TERM
