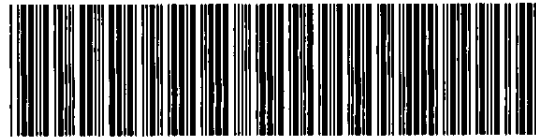

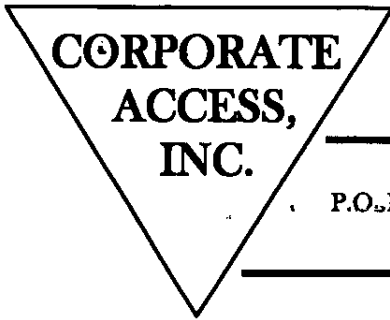

Pursuant to the provisions of Sections 607.1005 and 607.1006 of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

1. The name of the Corporation is Details Facility Solutions, Inc.
2. The following amendment to the Articles of Incorporation was adopted by the Incorporator of the Corporation on the 24 day of March, 2010, in the manner prescribed by the Florida Business Corporation Act:

- (a) Article 1 titled "Name" is hereby deleted and, in its place insert:

"The name of this Corporation shall be **SOUTHERN PINE HOLDINGS, INC.**"
