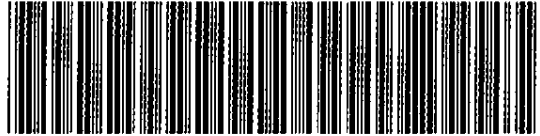

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE I.
NAME AND ADDRESS**

The name of the corporation shall be DelSis, Inc. (the "Corporation"). The address of the principal office of the Corporation shall be 7914-7918 Harbor Island Drive, North Bay Village, Florida 33141, and the mailing address shall be the same.

**ARTICLE II.


