## ARTICLES OF INCORPORATION

### ARTICLE I - NAME

The name of this Corporation is National Auto Parts Warehouse - CA, Inc.

### ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing upon filing of these Articles.


