**ARTICLE I.
NAME**

The name of this corporation is: Innovative Business Advantages, P.A.

**ARTICLE II.
DURATION**

The duration of this corporation is perpetual. The date and time of commencement of the corporate existence is the time of filing of the Articles of Incorporation by the Department of State of the State of Florida.

**ARTICLE III.
PURPOSES**

The purposes for which this corporation is initially organized are to engage in every phase and aspect of the general practice of accounting, rendering the same professional services to the public that an accountant, duly licensed under Florida laws is authorized to render, but such services will be rendered only through the corporation's officers, employees, and agents who are duly authorized under Florida laws to practice accounting. The corporation also may engage in any or all lawful business which professional service corporations practicing accounting may engage in under the Florida Professional Service Corporation Act.

**ARTICLE IV.
SHARES**

The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares of common voting stock having a par value of \$1.00 per share. The capital stock of this corporation may be issued for real or personal property, services, or any other right or thing having a value in the judgment of the Board of Directors at least equivalent to the full par value of the stock so to be issued, and, when so issued, such stock shall be fully paid and nonassessable.

**ARTICLE V.
PRINCIPAL OFFICE AND REGISTERED AGENT**

If any officer, stockholder, agent or employee of this corporation who has been rendering professional accounting services to the public, becomes legally disqualified to render such services within the State or accepts employment which, pursuant to existing laws, places restrictions or limitations upon his continued rendering of such professional services, he shall sever all employment with, and financial interest in, this corporation forthwith.

ARTICLE IX. VOTING TRUSTS

No shareholder of this corporation shall enter into a voting trust agreement or any other type of agreement vesting in another person the authority to exercise the voting power of any or all of his shares.

ARTICLE X. STOCKHOLDERS

Shares of this corporation's capital stock shall be issued only to individuals who are duly licensed to render services as an accountant under the laws of the State of Florida, or to professional corporations or professional limited liability companies legally authorized under the laws of the State of Florida to render professional accounting services.


