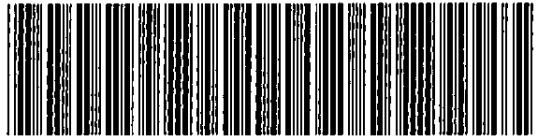

ARTICLES OF INCORPORATION

OF

SHALAMAR, INC.

ARTICLE I - NAME

The name of this Corporation is Shalamar, Inc. and the physical address is 10500 Mark Adam Road, Ocoee, Florida 34761, and the mailing address is P. O. Box 1042, Plymouth, Florida 32768.

ARTICLE II - TERM OF EXISTENCE

The existence of this Corporation shall exist perpetually.

ARTICLE III - NATURE OF BUSINESS

This Corporation may engage or transact in any or all activities or businesses permitted in the laws of the United States of America and the State of Florida.

ARTICLE IV - CAPITAL STOCK

No shareholder shall have the right to accumulate his or her votes at any election for the Board of Directors nor any other matter of this Corporation.

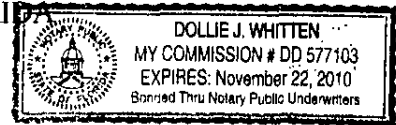
